TOPIC: **Climate Adaptation**

BIOS: Carrie Baron is a Civil engineering graduate of the University of Manitoba with over 29 years of experience in the municipal, water resources and environmental engineering fields. She is the Drainage & Environment Manager for the City of Surrey whose responsibilities include: overseeing the function of the natural and manmade drainage systems; floodplain and dyke management plus environmental initiatives. She has been involved in many regional and provincial advisory panels including the West Coast Sea Level Rise Experts panel, Fraser Basin Council Joint Partnership Committee, Metro Vancouver Environmental Monitoring Committee, BCWWA Climate Change Committee and the SFU ACT Climate Change Adaptation consortium.

Tamsin Lyle is principal and founding engineer with Ebbwater Consulting, a Vancouver based company that is wholly focussed on flood management. Over her 15-year career she has developed in-depth technical knowledge of flood mechanisms along with a broad understanding of flood policy and planning. She works

across the country to help communities mitigate their flood risk, and often speaks out on the need to manage floods in a holistic and integrated manner. She is currently the technical lead consultant for the City of Vancouver's coastal flood risk assessment.
